

# Your Guide to State Calling Restrictions.



Compliance can be complicated - but it doesn't have to be. In addition to remaining compliant with core TCPA 227(b) and 227(c)\* issues, the FCC (Federal Communications Commission) and individual states have additional regulations to keep in mind about your calling campaigns.

One of those issues is *when* you can call your contacts. For example, the FCC does not let you make “telephone solicitation” calls from 9 p.m. until 8 a.m. in the called party’s local time. But many states layer on their own time-of-day restrictions. The charts included only provide information for states that have rules that are more restrictive than the federal law; that restrict calling on weekends, holidays, or during states of emergency, or that limit call volume.

The following chart contains information regarding certain states’ permissible calling hours. Readymode is voluntarily providing this information to assist its customers in complying with such state laws. Many of these states’ calling restrictions are subject to exceptions. Those exceptions vary from state to state and are not addressed here. The relevant time for these states’ calling restrictions can differ. For example, for one state’s law, the relevant time may be the time in that state. For another state’s law, the relevant time may be based on the called party’s location.

## Calling Restrictions by Day and Time

Federal law allows businesses to make telemarketing calls between 8am and 9pm at the contact’s location. This chart outlines state-specific rules.

### Maximum Call Volume

This chart contains state-specific information about how frequently you can dial a specific number.

Maximum of 3 telemarketing calls to any consumer over a 24-hour period on the same subject matter or issue.  (Fla. Stat. § 501.616), (Md. Commercial Law Code Ann. § 14-4502 (effective 1/1/24)), (15 Okl. St. § 775C.4), (ORS § 646.563 (Amendment effective 1/1/26))	FL, MD, OK, OR

For the states that limit calling on holidays, a list of holidays is included that most of those states recognize on a recurring basis. Each state, however, may have other days that may be recognized as a holiday depending on the year, which are not included in the list. The governor of each state is also free to declare additional days as holidays.
